PREAMBLE

– a private religious corporation sole –

KNOW ALL PERSONS BY THESE PRESENTS: That, in accordance with **A BRANCH[®] CHARTER STATUTES** sealed on the Twelfth of August, 2003ⁱⁱ, the undersigned, **DAVID CARL LEWIS** for the purpose of overseeing this Order and Office under its own authority and jurisdiction, and in pursuance thereof does hereby this day sign and acknowledge the following CHARTER AMENDMENTS and Articles of Incorporation, and state(s) as follows:

The purpose of this document is: to form and become a corporation sole, in the manner prescribed in RCW Chapter 24.12, as nearly as may be; and, thereupon, said overseer, together with his successors in office or position, by his official designation, shall be held and deemed to be a body corporate, with all the rights and powers prescribed in the case of corporations aggregate; and with all the privileges provided by law for religious corporations.

 61 in common law and biblical records to which we intend to ABIDE.
- 62 2. Accordingly, we do herein incorporate as part and parcel with this document a tried
 63 and proven (KOHANE) guide, a long established model (MASHAL) for social order;
 64 In **The Holy Scriptures, both the old and new covenants we ABIDE.**
- 65 3. Furthermore, since we are blessed by this ancient yet pertinent document as our
 66 Initial Agent, it is therefore fundamental to all our messages (MALAK), beliefs,
 67 considerations, decisions, and actions, that we bless others, as we are blessed.
- 68 4. Justification of the BRANCH ABIDE is prepared and confirmed by Familial Blessings,
 69 Providence and Holy Spirit lead human interventions, declarations and rewards:

70 THESE ARE TRUTHS THAT WE ACKNOWLEDGE AND HEARTILY ENDORSE.

71 **See-MaKe BRANCH**, corporation sole is a not-for-profit religious servant (ABIDE)
 72 person(s) based on biblical law:

73 "WHEREFORE, the rather, **brethren, give diligence (ABIDE) to make your calling**
 74 **and election (HODE) sure:** for if ye do these things, ye shall never fall:" 2Peter 1:10

75 "*THUS SAITH YHWH Saba-oath, the LORD of hosts: If thou wilt (ABIDE) walk in my ways, and if*
 76 *thou wilt keep my charge, then thou shalt also judge my house, and shalt also keep my courts,*
 77 *and I will give thee places to walk among these that stand by.*

78 *HEAR NOW, O Joshua (Yah-of-shua, God of salvation) the high priest, thou, and thy fellows that*
 79 *sit before thee: for they are men wondered at: for, behold, I will bring forth my servant*

126 The following provides authority for the **Secretary of State**, for recorders of its various
127 counties, and/or their Registrar of Deeds to receive for filing on behalf of all people, as a
128 matter of record for public inspection, these Articles of Incorporation: Title 24, Chapter 12
129 of the Revised Code of Washington (24.12 RCW), and RCW 36.18.010 and 65.04.080 and
130 110.

ARTICLE 1
NAME OF CORPORATION

133 The name of this corporation sole is:

134 See-MaKe BRANCH, and His Successors, a corporation sole.

TERM OF EXISTENCE

137 The corporation is to have perpetual existence.

ARTICLE 3
PURPOSE

140 The purposes of **"SEE-MAKE" BRANCH**, corporation sole, is to do whatever will provide
141 for and promote the Kingdom Of God (YHWH), His Righteousness, abiding in His Law and
142 in the principals of Liberty, Justice, Mercy and Judgment; to provide for the comfort,
143 happiness and improvement of an indefinite number of natural men and women, the firm
144 and fair practice and lawful operation of the Law, providing lawful advice, educating
145 people in the fundamental principles of liberty and the Common Law, researching,
146 developing and implementing remedies at Law for any problem while holding accountable
147 those individuals responsible for the breach of, or wrongful interference with contractual
148 obligations, whether written, verbal, or implied; as well as other worthwhile projects for
149 the common good of **"SEE-MAKE" BRANCH** and its close associates, along with other
150 acts and programs beneficial to **"SEE-MAKE" BRANCH** at large.

151 **"SEE-MAKE" BRANCH** overseer is to promote YHWH's Kingdom among His
152 people, conduct charitable, educational, experimental, scientific or religious project actives
153 that in the opinion of the presiding **"SEE-MAKE" BRANCH** and his appointed advisers
154 tends to develop, promote, restore, maintain and extend the heritage of freedom on
155 Planet Earth, and is dedicated to establish and maintain the "Counsel of Peace" therein.

156 Therefore, as Providence provides, **"SEE-MAKE" BRANCH** intends to OVERSEE,
157 ORDER AND OFFICE the Program and Development of Ezekiel's Temple Complex and
158 related projects. Included By Reference: Zechariah 6:9-15 & Ezekiel 40-48.

ARTICLE 4
POWERS

161 1. The general character, powers and service of this corporation sole and the object and
162 purpose proposed, designed, promoted, developed, and maintained by the Servant
163 OVERSEER (ABIDE), Order (HODE MASHAL) and Office (MALAK KOHANE) are in the

164 spirit and language of The Holy Bible, Washington State RCW 24.12.020, and as
165 follows:

166 2. This corporation sole service, oversight, order and office is organized and operated
167 exclusively for service to YHWH.

168 (a) In addition, powers are hereby granted to this corporation sole to engage in actives
169 that further the design, development, building, operation, transfer and
170 management of its objectives.

171 (b) Power is granted to the corporation sole to hold property to him and his successor
172 in right of office under his own seal, in his own name and the name of this office.

173 (c) Power is granted to collect income from property held for the exclusive purpose of
174 collecting income therefrom and turning over the entire amount of such income,
175 less expenses, to the objects of this corporation.

176 3. In furtherance and clarification of and not in limitation of the general powers conferred
177 by the laws of the State of Washington, it is expressly provided that this corporation
178 sole Servant OVERSEER, Order and Office shall also have the following powers:

179 (a) To purchase or otherwise acquire, so far as permitted by law, the whole or any part
180 of the undertaking and business of any person, firm or corporation and the property
181 and liabilities, including the good will, assets and stock in trade thereof, and to pay
182 for the same either in cash or in shares, or partly in cash and partly in shares, or to
183 receive the same as a gift.

184 (b) To purchase or otherwise acquire, and to hold, maintain, work, develop, sell, lease,
185 exchange, hire, convey, mortgage, or otherwise dispose of and deal in, lands and
186 leaseholds, and in any interest, estate and rights in real property and any personal
187 or mixed property, and any franchises, rights, business or privileges necessary,
188 convenient and appropriate for any of the purposes herein expressed.

189 (c) To acquire by purchase, subscription, or otherwise, and to hold for investment or
190 otherwise, and to use, sell, assign, transfer, mortgage, pledge, or otherwise deal
191 with or dispose of stocks, bonds, or any obligations or securities of this or any
192 corporation or corporations; and to merge or consolidate with any corporation in
193 such manner as may be provided by law.

194 (d) To make and issue notes, bonds, debentures, obligations and evidences of
195 indebtedness of all kinds, whether secured by mortgage, pledge or otherwise,
196 without limit as to amount, except as may be prohibited by statute, and to secure
197 the same by mortgage, pledge or otherwise, and generally to make and perform
198 agreements and contracts of every kind and description.

199 (e) To conduct and carry on its business, or any part thereof, and to have one or more
200 offices, and to exercise all or any of its corporate powers and rights in the State of
201 Washington, and in the various states, territories, colonies and dependencies of the
202 United States, in the District of Columbia, and in all or any foreign countries or
203 country.

204 (f) To do all and everything necessary, suitable and proper for the accomplishment of
205 any of the purposes, or the attainment of any of the objects, or the furtherance of
206 any of the powers hereinabove set forth, either alone or in association with other

207 corporations, firms or individuals, and to do every act or acts, thing or things,
208 incidental or appurtenant to or growing out of or connected with the aforesaid
209 business or powers, or any part or parts thereof: Provided, the same be not
210 inconsistent with the laws under which this corporation is organized.

211 (g)To have such powers as are conferred upon corporations under the laws of this
212 state, and to engage in any lawful business.

213 ARTICLE 5
214 ORGANIZATION

215 **Servant OVERSEER (ABIDE)**

- 216 1. The principals in **"SEE-MAKE" BRANCH**, corporation sole are the Servant
- 217 OVERSEER and the Secretary Scribe.
- 218 2. The Servant OVERSEER, also known as, ABIDE, has full legal control and oversight
- 219 of all assets belonging to the **"SEE-MAKE" BRANCH**, corporation sole. The ABIDE
- 220 is akin to the Director/Chairman/President of a corporation.

221 **Secretary Scribe (SAPPHIRE)**

- 222 1. The Secretary Scribe, also known as, SAPPHIRE Secretary, is akin to the Secretary
- 223 of a corporation and is the REGISTERED AGENT.
- 224 2. The OVERSEER and Secretary may or may not be related to each other.
- 225 3. No other officers and no by-laws will be required.

226 ARTICLE 6
227 DUTIES AND DISSOLUTION

228 The duties and responsibilities of **"SEE-MAKE" BRANCH** shall be in the **Kingdom of God**
229 on the Earth, and throughout the fullness of all the land.

230 **Servant OVERSEER (ABIDE)**

- 231 1. The ABIDE, servant overseer, is the incorporator.
- 232 2. **"SEE-MAKE" BRANCH** corporation sole has no government reporting
- 233 requirements. Statutory courts recognize a corporation sole is immune from
- 234 government regulation, taxation, licensing requirements, etc.
- 235 3. The authority of the OVERSEER, Order and Office to make By-Laws for the
- 236 corporation is hereby expressly vested in the ABIDE of this corporation. Subject to
- 237 the power of such By-Laws, A Board of Elders, Cabinet or other such appointed
- 238 body shall not make or alter any By-Laws fixing their qualifications, classifications,
- 239 terms of office or powers without first securing the approval of the ABIDE.
- 240 4. The ABIDE reserves the right to amend, alter, change or repeal any provision
- 241 contained in these Articles of Incorporation in the manner now or hereafter
- 242 prescribed by statute, and all rights conferred on the corporation herein are granted
- 243 subject to this reservation.
- 244 5. **"SEE-MAKE" BRANCH**, Corporation sole, ABIDE Servant OVERSEER's role and
- 245 responsibility is spelled out plainly in Zechariah 6:12. Then speak to him, saying,
- 246 'Thus says YHWH Saba-oath , saying: *"Behold, the Man whose name is the*
- 247 *BRANCH! From His place He shall branch out (see and make), And He shall build*
- 248 *the temple of YHWH; 13 Yes, He shall build the temple of YHWH. He shall bear the*
- 249 *glory, And shall sit and rule (MASHAL) on His throne; So He shall be a priest*
- 250 *(KOHANE) on His throne, And the counsel of peace shall be between them both."*

251 **Secretary Scribe (SAPPHIRE)**

- 252 1. The Scribe: is anyone that develops and maintain records for **"SEE-MAKE"**
- 253 **BRANCH**, such as; Secretary, Treasure, Controller, Chief Financial Officer,
- 254 Engineering Records Officer, and Legal and Code Officers, etc. These Officers are
- 255 retained on a need bases and are subject to the ABIDE OVERSEER.
- 256 2. The OVERSEER will designate a SAPPHIRE Secretary for **"SEE-MAKE" BRANCH**,
- 257 and that named Scribe will be the designated RESIDENT AGENT for the corporate
- 258 sole.
- 259 3. The **"SEE-MAKE" BRANCH** SAPPHIRE Secretary will file with the Secretary of
- 260 State a certificate of acceptance within 30 days.
- 261 4. Upon resignation the **"SEE-MAKE" BRANCH** SAPPHIRE Secretary will file a signed
- 262 statement that he/she is unwilling to act as the agent of the corporation for service
- 263 of process. The execution of the statement must be acknowledged.

264 **ABIDE Successor**

- 265 1. The successor(s) to this office is named and sealed by the OVERSEER/ABIDE in
- 266 office, and verified by affidavit signed by two or more witnesses.
- 267 2. In the event of voluntary dissolution, the net assets will be distributed as follows:
- 268 one hundred percent to the nation/state of Israel.

269 **ARTICLE 7**
270 **INCORPORATOR**
